Noble Company in the amount of \$1,809,327, which consists of the base bid, additive alternate bid items A-1 and A-2, and deductive bid item D-1;
2. Authorize the Public Works Director/City Engineer to process change orders in an amount not to exceed 10% of the total contract for \$180,933, for a total not-to-exceed amount of \$1,990,260 if needed;
3. Authorize the City Manager to execute the Construction Contract for the Niguel Road Pavement Rehabilitation (Highlands Avenue to Marina Hills Drive) Project, Cash Contract No. 20-10 with R.J. Noble Company, subject to the City Attorney making non-substantive changes; and,
4. Authorize the Public Works Director/City Engineer to execute Future Contract Documents at the conclusion of construction.

8. Approval of Plans and Specifications for the Paseo de Colinas Groundwater Seepage Repair Project, Cash Contract No. 20-12, and Authorization to Advertise the Project for Bids

Recommendation

Staff recommends that the City Council:

1. Approve the Plans and Specifications for the Paseo de Colinas Groundwater Seepage Repair Project, Cash Contract No. 20-12; and
2. Authorize staff to advertise the project for bids.

9. Approval of Maintenance Services Agreement for Citywide On-Call Tree Trimming Services with Great Scott Tree Service, Inc.

Recommendation

Staff recommends that the City Council:

1. Award the Maintenance Services Agreement for Citywide On-Call Tree Trimming Services to Great Scott Tree Service, Inc. in the not-to-exceed amount of \$185,000 per year for Fiscal Years 2020-21 through 2022-23, subject to extension administratively for two additional one-year periods;
2. Approve a not-to-exceed 20% contingency per year of the total contract in the amount of \$37,000 per year for Fiscal Year 2020-21 through 2022-23 for unforeseen conditions or additional work and authorize the Public Works Director/City Engineer to approve change orders to the agreement with Great Scott Tree Service, Inc., for a total not-to-exceed amount of \$222,000 per year if needed; and,
3. Authorize the City Manager to execute the Maintenance Services Agreement and future amendments to the agreement for Citywide On-Call Tree Trimming Services with Great Scott Tree Service, Inc., subject to the City Attorney making non-substantive changes.

10. Notices of Completion for Crown Valley Park Improvement Project, Tier III

Recommendation

Staff recommends that the City Council:

1. Accept as complete the Crown Valley Park Improvement Project, Tier III;
2. Authorize recordation of the Notices of Completion for said project;

2. Approve a not-to-exceed 20% per year contingency of the total contract in the amount of \$24,785 per year for Fiscal Years 2020-21 through 2022-23 for unforeseen conditions or additional work and authorize the Public Works Director/City Engineer to approve change orders to the agreement with Georay Technologies, Inc. dba Boone Action Turf, for a total not-to-exceed amount of \$148,714 per year if needed; and,
3. Authorize the City Manager to execute the Maintenance Services Agreement and future amendments to the agreement for Synthetic Sports Turf and Facilities Maintenance Services with Georay Technologies, Inc. dba Boone Action Turf (Boone Action Turf), subject to the City Attorney making non-substantive changes.
