

Building Division Fees Schedule (Effective July 1, 2025)

- In accordance with the City Council Resolution No. 91-129 establishing fees for the Building Division, increases have been made to the construction valuation and non-valuation permit fees based upon changes in the Los Angeles Construction Cost Index (CCI) published by the Engineering News Record (ENR).

- Technology Cost Recovery will be 2% of building plan check and permit fees.
- General Plan Cost Recovery will be 2% of building plan check and permit fees.
